

# DEPAC Weekend Shoot info:

The following pages contain information you may find helpful in planning to attend the shoot.

## Stuff to Bring:

You'll want to bring a few outfits with you to shoot. We suggest:

### For dance/contortion pictures:

- Leotards
- Rehearsal wear: Leggings, shorts, halter tops, sports bras, tank tops, etc
- Recital/competition costumes

### For regular portrait pictures:

- 2 pairs of pants
- 1 pair of shorts or a skirt
- 3 tops to match the above
- 1 dress

Bring some shoes to go with your outfits, any accessories you'd like (hats, belts, jewelry, etc). If you have any special hair or makeup needs please bring those products with you.

### So, what's this all about anyway?

DEPAC and Jaze Companies have organized this special free group shoot weekend just for you! June 1st and 2nd the Dayton Studio Collective will be all yours for 2-days of photoshoot fun! We hope you'll consider joining us. The weekend will consist of dance, contortion, portrait and other creative shooting opportunities.

### I'm not familiar with Model Releases, in plain english, what exactly am I signing?

Releases are common-place tools at many other venues - especially where physical activity takes place. Model releases are an industry standard practice. A model release spells out the rights and permissions both parties have with regard to how the images can (or can't) be used. If your child is a minor it also signifies your consent for us to take their picture and that you won't sue us if, included in the pictures returned to you, there are some blurry pictures or ones with your child's eyes closed. While our studios are safe places for all ages, it also releases us from liability of accidental injury that could occur during the course of the shoot - especially where dance and other physical activity is taking place. If you have any specific questions related to the release terms please contact the studio. A signed release will be required in order to participate. Please print and fill out the release below and bring it to the shoot.

### Do you do re-touching?

We will return all photos to you via google drive using the email address provided on the release form. We typically return all images to the client first unedited within 48hrs of the shoot. We then ask the client to review

the images and select their favorite 2 or 3 images from each outfit. We'll then do basic retouching to those images and provide you back the final edited versions. Digital copies of final edited versions of your selected photos is also included at no additional charge.

### Sunday Milk Bath Workshop

Sunday June 2nd we're providing a special opportunity for attendees to participate in a milk bath workshop. Milk bath photos are a unique style of portrait photography and we're excited to make this opportunity available to you. The Sunday Milk Bath shoot is optional (so if it's not your thing that's totally fine). There is NO additional cost to participate in the Sunday workshop.

#### For Milk Bath pictures you'll want to wear:

- Black bandeau top/tube top
  - While there are some stylistic differences between brands generally what you're looking for is something like [this](#):

- Black boyshorts or bikini bottoms
  - Note: We recommend boyshort bottoms as they tend to shoot better and cooperate a little better in the pool and movement/posing of the model. But, wear what your most comfortable in.
  - These items are generally available at your local Target or Walmart - tops are typically found in the undergarments section of the store. Boyshorts/spunks/volleyball shorts and other similar style bottoms can be found either in the undergarment, sporting or athletic depts. Nylon/Spandex/Synthetic blends perform better than cotton.
  - Since you will be in water and these will get wet color is important. Please stick solid black. DO NOT bring white, tan, beige, etc
- Towels for drying off and a plastic bag to put wet clothes/towels in.

#### Other Common Questions:

**Q: Do you use actual milk?** A: No, we use a combination of water and powdered creamer to create the effect. When milk comes in contact with hot water it begins to spoil and the smell can get stuck in the models hair. We avoid actual milk for other sanitary reasons as well.

**Q: Is this cold?** A: Because we use powdered creamer we're able to use warm water. These shoots are also done indoors.

**Q: Where are these photos used?** A: Jaze Companies will not use any milk bath photos from this workshop publicly without first obtaining your express consent. You, however, are welcome to post them and/or share with family privately or online.

**Q: How will my child be portrayed in these images?** A: Most of our milk bath shoots are with minors - we'll ensure the images taken are age appropriate. Some additional samples can be seen on the event webpage where you downloaded this form.

**General Weekend Itinerary/Information (preliminary)**

**Saturday:**

Noon: Arrive at the studio, get settled in and brief orientation.

12:30 - 7p: Shooting (combination of dance, contortion and regular portraits all by model's choice. End time is approximate and may adjust based on total number of attendees. Shooting will take place round-robin style.

**Sunday:**

Noon: Arrive at the studio, brief milk bath orientation

12:15 - 5p: Milk Bath workshop. Shooting will take place round-robin style.

# Modeling Release - DEPAC Shoot

In consideration of the engagement as a model of the minor named below, and for other good and valuable consideration that I acknowledge as having received, I hereby grant the following rights and permissions to Jaze Photography ("Photographer"), their legal representatives and assigns, those for whom Photographer is acting, and those acting with their authority and permission:

- I grant the absolute right and permission to take photographic portraits or pictures of myself/the minor or in which I/the minor may be included, in whole or in part, or composite or distorted in character or form as it pertains to the birthday party event.
- I acknowledge that photographs of myself/the minor taken at this event are strictly for non-commercial purposes. Images taken at this event will not be made available for sale or otherwise distributed for profit by either party.
- I specifically consent to the digital compositing or distortion of the portraits or pictures, including without restriction any changes or alterations as to color, size, shape, or perspective.
- I affirm the email address I have included below is accurate as it will be used to provide me copies of the pictures taken of myself/minor child.
- I understand that digital copies of the pictures will be provided to me via this email address and that I'm free to use these images for personal use and that I have no obligation to purchase further or additional services from the photographer. I understand that personal-use prints are optional and may include an additional charge. I can purchase these through the studio or on my own.
- I release, discharge, and agree to hold harmless and defend Photographer, their legal representatives or assigns, and all persons acting under their permission or authority or those for whom they are acting, from any liability by virtue of any reason in connection with the making and use of such photographs, including blurring, distortion, alteration, optical illusion, or use in composite form, whether intentional or otherwise, that may occur or be produced in the taking of said picture or in any subsequent processing thereof. Including without limitation any claims for libel or violation of any right of publicity or privacy. This same release applies to any physical injury sustained during their engagement as a model at this event.
- I hereby warrant that I am a legal competent adult and a parent or legally appointed guardian of the minor, and that I have every right to contract for myself/the minor in the above regard.
- I state further that I have read the above authorization, release, and agreement, prior to its execution, and that I am fully familiar with the contents of it.

This release shall be binding upon the minor and me, and our respective heirs, legal representatives, and assigns.
