

Dent Model Shoot info:

The following pages contain information you may find helpful in planning to attend the shoot.

Stuff to Bring:

You'll want to bring a few outfits with you to shoot. We suggest:

For dance/cheer pictures:

- Leotards, Tutu's, pointe shoes, etc
- Rehearsal wear: Leggings, shorts, halter tops, sports bras, tank tops, etc (whatever your comfortable with)
- Recital/competition costumes or uniforms

For regular portrait/modeling pictures:

- 3 pairs each of pants, shorts
- 3 skirts
- 9 tops to match the above
- 2 dresses
- 2 swimsuits (these will be used to assemble to posing study guide for the model to use at home practicing/learning posing. These images will not be used/posted publicly).

Bring some shoes to go with your outfits, any accessories you'd like (hats, belts, jewelry, etc). Also, bring any hair or makeup supplies you might need.

The shoot will take place at the Dayton Studio Collective: 400 Linden Ave, Dayton OH. We recommend downloading this PDF for parking [directions](#) to the studio.

So, what's this all about anyway?

Dent and Jaze Companies have organized this special shooting opportunity just for Dent models! We know that photography session can be expensive. Having quality photos and good instruction is critical for new and intermediate models wanting to advance their modeling career. We're all about providing helpful and valuable services for models so we decided to offer our photography services to models outside our marketing who would be willing to travel to us to shoot.

We recognize that technically the shoot isn't totally free since you're responsible for the travel-related expenses but our hope is the savings would still be a benefit to you. If you make trip, we'll shoot with you no charge.

I'm not familiar with Model Releases, in plain english, what exactly am I signing?

Releases are common-place tools at many other venues - especially where physical activity takes place. Model releases are an industry standard practice. A model release spells out the rights and permissions both parties have with regard to how the images can (or can't) be used. If your child is a minor it also signifies your consent for us to take their picture and that you won't sue us if, included in the pictures returned to you, there are some blurry pictures or ones with your child's eyes closed. While our studios are safe places for all ages, it also releases us from liability of accidental injury that could occur during the course of the shoot - especially where dance and other physical activity is taking place. If you have any specific questions related to the

release terms please contact the studio. A signed release will be required in order to participate. Please print and fill out the release below and bring it to the shoot.

Do you do re-touching?

We will return all photos to you via google drive using the email address provided on the release form. We typically return all images to the client first unedited within 48hrs of the shoot. We then ask the client to review the images and select their favorite 2 or 3 images from each outfit. We'll then do basic retouching to those images and provide you back the final edited versions. Digital copies of final edited versions of your selected photos is also included at no additional charge.

About the Posing Study Guide

When we work with model on helping them prepare for their career we invest heavily in helping models become proficient at posing on their own. Posing is an integral part of a model's responsibility. A commercial mode's value is heavily impacted by their ability to pose efficiently and effectively. As part of our shoot session will include a posing instruction and study session. This session help models understand important concepts like posture and body carriage as well as how to efficiently move on-set and in front of the camera so that posing is fluid, efficient and always portraying the model in the best way possible.

In order to models to be able to see and assess how their body reacts to different poses we do the posing study in a swimsuit. The session will include tips and tricks on how to always look your best, how to get the most out of posing on your own and images collected during this session will serve the model as a study guide for learning and memorizing poses. It's important to note that the images collected during the posing session will NOT be posted or used publicly. These are strictly for the model to use as a reference tool.

Steampunk Sessions

Interested in a truly unique photography experience? Interested models can add this unique concept to their portfolio. These shoots are both fun and creative, plus it's not something you can get just anywhere! Steampunk is a style of design and fashion that combines historical elements and typically features steam-powered machinery rather than advanced technology. Generally clothing is consistent with victorian-era attire and is often decorated with gears, chains and other items commonly found in the steam-technology era. There's no additional cost to add a steampunk session to your shoot. We'll provide wardrobe and props (with a few restrictions we want to make you aware of:

- **Wardrobe:** We have a few garment pieces available models may use for this session. A model's participation in this session is dependent on their ability to fit into the wardrobe we have available. We'll want to talk sizes and fit in advance. Please bring black undergarments to wear underneath.
- **Props/Accessories:** We have a limited stock of related props that models may use for this session. Props include goggles, top hat, lace parasol and other items maybe be available.
- **Footwear:** We have a limited option of footwear available but due to variability in sizing we recommend models bring black heels or chunky boots with them for this concept that you're sure they will fit comfortably.
- **Makeup:** Models should bring bring red lipstick and some brown or black powder to create "dirt smudges" on their face.

Modeling Release - Dent Shoot

In consideration of the engagement as a model of the minor named below, and for other good and valuable consideration that I acknowledge as having received, I hereby grant the following rights and permissions to Jaze Photography ("Photographer"), their legal representatives and assigns, those for whom Photographer is acting, and those acting with their authority and permission:

- I grant the absolute right and permission to take photographic portraits or pictures of myself/the minor or in which I/the minor may be included, in whole or in part, or composite or distorted in character or form as it pertains to the group shoot event.
- I acknowledge that photographs of myself/the minor taken at this event are strictly for non-commercial purposes. Images taken at this event will not be made available for sale or otherwise distributed for profit by either party.
- I specifically consent to the digital compositing or distortion of the portraits or pictures, including without restriction any changes or alterations as to color, size, shape, or perspective.
- I affirm the email address I have included below is accurate as it will be used to provide me copies of the pictures taken of myself/minor child.
- I understand that digital copies of the pictures will be provided to me via this email address and that I'm free to use these images for personal use and that I have no obligation to purchase further or additional services from the photographer. I understand that personal-use prints are optional and may include an additional charge. I can purchase these through the studio or on my own.
- I release, discharge, and agree to hold harmless and defend Photographer, their legal representatives or assigns, and all persons acting under their permission or authority or those for whom they are acting, from any liability by virtue of any reason in connection with the making and use of such photographs, including blurring, distortion, alteration, optical illusion, or use in composite form, whether intentional or otherwise, that may occur or be produced in the taking of said picture or in any subsequent processing thereof. Including without limitation any claims for libel or violation of any right of publicity or privacy. This same release applies to any physical injury sustained during their engagement as a model at this event.
- I hereby warrant that I am a legal competent adult and a parent or legally appointed guardian of the minor, and that I have every right to contract for myself/the minor in the above regard.
- I state further that I have read the above authorization, release, and agreement, prior to its execution, and that I am fully familiar with the contents of it.

This release shall be binding upon the minor and me, and our respective heirs, legal representatives, and assigns.
