The following pages contain information you may find helpful in planning to attend the party.

Stuff to Bring:

You'll want to bring a few outfits with you to shoot. We suggest:

- 2 pairs of pants
- 1 pair of shorts or a skirt
- 3 tops to match the above
- 1 dress

Bring some shoes to go with your outfits, any accessories you'd like (hats, belts, jewelry, etc). If you have any special hair or makeup needs please bring those products with you.

The shoot will take place at the Dayton Studio Collective. We recommend downloading this PDF for [driving directions](#) to the studio.

So, what's this all about anyway?

Isabella has decided to host a "modeling photoshoot" as her birthday party. Isabella and her guests will participate in a modeling photography session at our studios. Your child will get one-on-one as well as group shooting time with our photographer. We'll be shooting a mix of casual and dressy looks and the spirit of the shooting event will be light and casual with an emphasis on fun.

I'm not familiar with Model Releases, in plain english, what exactly am I signing?

Releases are common-place tools at many other venues - especially where physical activity takes place. Model releases are an industry standard practice. A model release spells out the rights and permissions both parties have with regard to how the images can (or can't) be used. Since your child is minor it signifies your consent for us to take their picture and that you won't sue us if, included in the pictures returned to you, there are some blurry pictures or ones with your child's eyes closed. While our studios are safe places for children, it also releases us from liability of accidental injury that could occur during the course of the party. If you have any specific questions related to the release terms please contact the studio. A signed release will be required in order for your child to participate. Please print and fill out the release below and have your child bring it to the party.

Do you do re-touching?

We will return all photos of your child to you via google drive using the email address provided on the release form. We typically return all images to the client first unedited within 48hrs of the shoot. We then ask the client to review the images and select their favorite 2 or 3 images from each outfit. We'll then do basic retouching to those images and provide you back the final edited versions. Digital copies of final edited versions of your selected photos is also included at no additional charge.

Modeling Release - Modeling Party

In consideration of the engagement as a model of the minor named below, and for other good and valuable consideration that I acknowledge as having received, I hereby grant the following rights and permissions to Jaze Modeling ("Photographer"), their legal representatives and assigns, those for whom Photographer is acting, and those acting with their authority and permission:

- I grant the absolute right and permission to take photographic portraits or pictures of the minor or in which the minor may be included, in whole or in part, or composite or distorted in character or form as it pertains to the birthday party event.
- I acknowledge that photographs of the minor taken at this event are strictly for non-commercial purposes. Images taken at this event will not be made available for sale or otherwise distributed for profit by either party.
- I specifically consent to the digital compositing or distortion of the portraits or pictures, including without restriction any changes or alterations as to color, size, shape, or perspective.
- I affirm the email address I have included below is accurate as it will be used to provide me copies of the pictures taken of my minor child.
- I understand that digital copies of the pictures will be provided to me via this email address and that I'm free to use these images for personal use and that I have no obligation to purchase further or additional services from the photographer. I understand that personal-use prints are optional and may include an additional charge. I can purchase these through the studio or on my own.
- I release, discharge, and agree to hold harmless and defend Photographer, their legal representatives or assigns, and all persons acting under their permission or authority or those for whom they are acting, from any liability by virtue of any reason in connection with the making and use of such photographs, including blurring, distortion, alteration, optical illusion, or use in composite form, whether intentional or otherwise, that may occur or be produced in the taking of said picture or in any subsequent processing thereof. Including without limitation any claims for libel or violation of any right of publicity or privacy. This same release applies to any physical injury minor sustains during her engagement as a model at this event.
- I hereby warrant that I am a legal competent adult and a parent or legally appointed guardian of the minor, and that I have every right to contract for the minor in the above regard.
- I state further that I have read the above authorization, release, and agreement, prior to its execution, and that I am fully familiar with the contents of it.

This release shall be binding upon the minor and me, and our respective heirs, legal representatives, and assigns.
